He said that Cheryl Ramos and John Barr will be working with both adult education and ABLE/GED. He said that service is the new mantra for adult education. Mr. Polen distributed enrollment information, for adult education, for the 2014-2015 and 2015-2016 school years. Full-time classes will begin September 1, 2015. The application deadline for the Friends of Adult Education Scholarships has been extended to August 21. He also told the Board about some of the community outreach that the adult education department has been involved in or plans to do.

SUPERINTENDENT'S REPORT

Bob Alsept, Superintendent, reported that the opening days for staff and students were very successful. 642 students attended orientation. There are currently 455 Juniors and 276 Seniors in the building. That is an increase from the previous year. He also told the Board that the students enjoyed the Buckeye Palooza. Mr. Alsept also distributed a handout from the people constructing the Rover Pipeline. It explains the tax benefits to the counties that the pipeline will be in. Mr. Alsept also gave the Board information from the Chamber of Commerce about the initiative to legalize marijuana. He said that there is a great deal of concern about the availability of marijuana to students if it is legalized. He suggested that the Board discuss adopting a resolution opposing this initiative. He said that the Board may be approached to use the building for a forum to discuss the issue.
